The Board of Directors of the Company has fixed the close of business on June 16, 2022 (New York time) as the record date (the "Record Date") for determining the shareholders entitled to receive the notice of the AGM or any adjournment or postponement thereof. Holders of record of the Company's ordinary shares at the close of business on the Record Date are entitled to attend and vote at the AGM and any adjournment or postponement thereof. Holders y shares ("ADSs") representing the Company's Class A ordinary shares at the close of business on the Record Date must act through the depositary of the Company's ADS program, The Bank of New York Mellon.
